ELECTRONIC INCORPORATION TERMS AND CONDITIONS

Articles of Incorporation submitted during system difficulties will receive an endorsement date effective the date the articles are updated to the ONBIS system.
- 5) The electronic Articles of Incurporation must be in the format approved by the Ministry and submitted through one of the Service Providers under contract with the Ministry.
