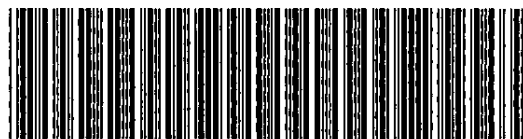



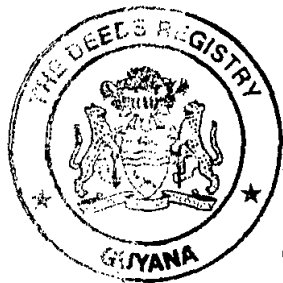

THIS TRUST DEED is made and executed on this 27th day of February, 2013 by and between DELMAR SHELDON MANAWAR, President, ODIANA TYRRELL, Vice President and ALECHIA AMOS, Secretary, all of 176 De Abreu Street, New Town Kitty, Georgetown, Guyana (hereafter referred to as "the Trustees"),

of "CHILDREN MUST BE FED, BE COMMITTED TO EXCELLENCE BECAUSE IN GOD WE TRUST" situated at 176 De Abreu Street, New Town Kitty, Georgetown, Guyana. For PRACTICAL PURPOSES the name used in the United States of America will be CHILDREN MUST BE FED INTERNATIONAL. The TRUSTEES of the said "CHILDREN MUST BE FED, BE COMMITTED TO EXCELLENCE BECAUSE IN GOD WE TRUST" declare:

WHEREAS the objectives for which the Organization is established:

- (a) To provide humanitarian aid (medical, clothing and food to less fortunate children in depressed communities especially those children whose parents have been victims of the AIDS epidemic throughout Guyana regardless of religion, race, gender or creed.
- (b) To develop and execute community projects.
- (c) To facilitate overseas humanitarian aid teams and donors in Guyana for charitable purposes.
- (d) To give support and aid to children and adults in the form of care, schooling and housing.

AND WHEREAS the said Organization has declared that it shall at all times and in all matters endeavor to promote and fulfill the purposes of the Organization and shall conduct its works and affairs in compliance with the Covenant Constitution and By-laws of the Organization.

AND WHEREAS the Organization is desirous of vesting duties and rights in the Trustees and their successors in office,

AND WHEREAS the Trustees are willing to accept the rights and duties which will be conferred upon them under this Deed.

NOW THE DEED WITNESSETH AS FOLLOWS:

1. IT IS HEREBY AGREED AND DECLARED that the present Trustees and their survivors or other Trustees for the time being of this Deed will be responsible for all properties situated and belonging to "CHILDREN MUST BE FED, BE COMMITTED TO EXCELLENCE BECAUSE IN GOD WE TRUST" , for all or any of the following purposes, namely:

- (i.) Striving to do and perform all the covenants set out from paragraph (a) to (d) hereinbefore set out and
- (ii.) For the purpose (s) which the member shall in their discretion think directly or indirectly conducive to assist or benefit the achievement of its objectives.

2. THE TRUSTEES shall keep and manage all prosperities whether movable or immovable, real or personal and any other building which may or may hereafter be erected by them and receive all monies and income and take payments in connection therewith.

3. THEY shall have the custody of all Deeds and documents relating to all properties and shall be responsible for the same.

4. THE TRUSTEES shall from time to time make, prescribe, and alter rules for meetings in connection therewith and of the mode and manner of convening such meetings and the conduct and proceedings there at and otherwise, as they may think fit.

5. If any of the Trustees hereafter named or hereafter appointed shall cease to be a TRUSTEE of these presents in the following circumstances.

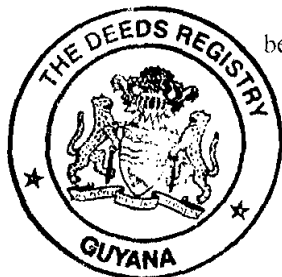
- (a) If he/she resigns from his/her appointment as a Trustee
