FOURTH RESTATED AND AMENDED CERTIFICATE OF INCORPORATION OF BANCINSURE, INC.

BancInsure, Inc., a corporation organized and existing under the General Corporation Law of the State of Oklahoma, does hereby certify:

- 1. The Articles of Incorporation were originally filed with the Secretary of State of the State of Oklahoma on March 7, 1985.
- 2. The Restated and Amended Certificate of Incorporation was approved by the Insurance Commissioner of the State of Oklahoma on November 16, 1989, and filed with the Secretary of State of the State of Oklahoma on November 16, 1989.
- 3. The Second Restated and Amended Certificate of Incorporation was approved by the Insurance Commissioner of the State of Oklahoma on March 24, 1994, and filed with the Secretary of State of the State of Oklahoma on April 5, 1994.
- 4. The Third Restated and Amended Certificate of Incorporation was approved by the Insurance Commissioner of the State of Oklahoma on March 14, 1995, and filed with the Secretary of State of the State of Oklahoma on March 16, 1995.
- 5. The following is the Fourth Restated and Amended Certificate of Incorporation which supersedes and takes the place of the therefore existing Third Restated and Amended Articles of Incorporation and amendments thereto, in accordance with OKLA. STAT. Title 18 Section 1080.

FOURTH RESTATED AND AMENDED CERTIFICATE OF INCORPORATION OF BANCINSURE, INC.

ARTICLE 1. The name of the Corporation is:

INSURANCE COMMISSIONER OKLAHOMA

RED ROCK INSURANCE COMPANY

ARTICLE 2. The address of its registered office in the State of Oklahoma is: 5104 N. Francis Avenue, Suite 101, Oklahoma City, Oklahoma 73118. The name and address of its registered agent is: Lisa G. Bays, 5104 North Francis Avenue, Suite 101, Oklahoma City, Oklahoma 73118. The principal place of business shall be Oklahoma City, Oklahoma, and the Corporation shall transact business in Oklahoma.

ARTICLE 3. The duration of the Corporation is for perpetuity.

ARTICLE 4. The general purpose for which this corporation is formed is to engage in business as a stock insurer as defined and authorized by the laws of the State of Oklahoma. The Corporation will transact Accident and Health Insurance as defined in OKLA. STAT. Title 36 Section 703, Property Insurance as defined in OKLA.STAT. Title 36 Section 704, Marine Insurance as defined in OKLA. STAT. Title 36 Section 705, Vehicle Insurance as defined in OKLA. STAT. Title 36 Section 707, and Surety Insurance as defined in OKLA. STAT. Title 36 Section 708.

ARTICLE 5. The aggregate number of shares which the Corporation shall have authority to allot is 500,000 shares of common stock, all of one class, or the par value of \$7.00 each, with the aggregate par value of authorized common stock totaling \$3,500,000.00. The shares will be non-assessable.

The designation of each class, the number of shares of each class, and the par value of the shares of each class are as follows:

ARTICLE 6. The amount of stated capital with which the Corporation shall begin business is \$500.00, which has been fully paid.

ARTICLE 7. There shall be allotted by the Corporation, before it shall begin the business of insurance, 500,000 shares of common stock, and the consideration to be received by the Corporation therefor will be the sum of \$500,000.00, capital.

The number and class of shares to be allotted by the Corporation before it shall begin the business of insurance and the consideration to be received by the Corporation therefor, are:

ARTICLE 8. Each shareholder of the Corporation shall be entitled at the shareholders meeting to one vote for each share standing in the name of such shareholder in the books of the Corporation.

ARTICLE 9. The Corporation shall have at least three (3) and no more than fifty (50) directors.

ARTICLE 10. The Corporation is authorized to issue participating policies according to the terms of OKLA. STAT. Title 36 Section 2121.

ARTICLE 11. The transfer of certificates of shares and the shares represented thereby may be regulated by the Bylaws, insofar as not inconsistent with the provisions of the Business Corporation Act of Oklahoma.

ARTICLE 12. In furtherance and not in limitation of the powers conferred by the laws of the State of Oklahoma, the Board of Directors of the Corporation is expressly authorized:

- (a) To adopt, alter, amend or repeal the Bylaws subject to the power of the shareholders to alter, amend or repeal such Bylaws; provided, however, the Board of Directors shall not adopt or alter the Bylaws fixing their number, qualifications, classifications, or term of office.
- (b) To designate, by resolution passed by a majority of the whole Board, one or more committees, each to consist of one or more directors, which committees, to the extent provided in such resolution or in the Bylaws of the Corporation, shall have and may exercise any and all of the powers of the Board of Directors in the management of the business and affairs of the Corporation.

ARTICLE 13. "A Director of the Corporation shall not be personally liable to the Corporation or its stockholders for monetary damages for breach of fiduciary duty as a director, except for liability (i) for any breach of the director's duty of loyalty to the Corporation or its shareholders, (ii) for acts or omissions not in good faith or which

involve intentional misconduct or a knowing violation of law, (iii) under OKLA. STAT. Title 18 Section 1053, or (iv) for any transaction from which the director derived an improper personal benefit; provided, however, that this paragraph shall be subject to the limitations, if any of OKLA. STAT. Title 18 Section 1002. If the Oklahoma General Corporation Act hereafter is amended to further eliminate or limit the liability of a director, then a director of the Corporation, in addition to the circumstances in which a director is not personally liable as set forth above, shall not be liable to the fullest extent permitted by the amended Oklahoma General Corporation Act.

Any repeal or modification of the foregoing paragraph by the shareholders of the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.
