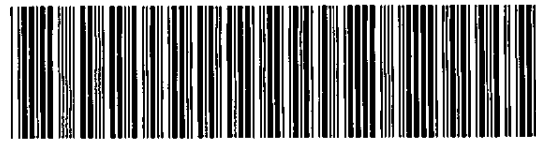



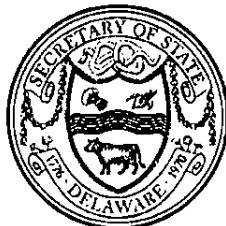

1. The Certificate of Incorporation of the Corporation is hereby amended by changing Articles First and Second to read as follows:


First: The name of the corporation is XPO Drayage, Inc. (the "Corporation").
