

We, the undersigned, ELCIO SALGADO (Elder of the Church), BRUNHILDA SALGADO, JUANA McCAVERA, CAROL ARDITO, and ANTHONY ARDITO, all being persons of full age, of whom at least two-thirds are citizens of the United States and at least one of whom is a resident of the State of New York, for the purpose of incorporating FAITH THAT PLEASES GOD CHURCH, INC., an unincorporated Protestant Church, pursuant to Article 10 of the Religious Corporations Law, do hereby make, execute, and acknowledge this Certificate as follows:

FIRST: That notice of meeting called for the purpose of deciding whether such unincorporated Church should become incorporated, was given as required by Section 191 of the Religious Corporations Law and such meeting was held at the time and place specified in such notice to wit, at 3405 Filmore Avenue, Brooklyn, New York, on the 2nd day of February 1983, and conducted in conformity with Section 192 of said law.
