

Under Article 10 of the Religious Corporation Law We, the undersigned, Rev. Albert Delmadge, presiding officer and Alton Graham and Lurlanda Dewar do hereby certify as follows:

- A notice of the meeting of the members of CHRISTIAN HERITAGE CHURCH, INC. to determine whether such Congregation should be incorporated, was duly given in pursuance of \$191 and 193 of the Religious Corporations Law, and such meeting was held in accordance therewith on the 21st day of August, 1987, at 7:30 p.m. o'clock of such day.


