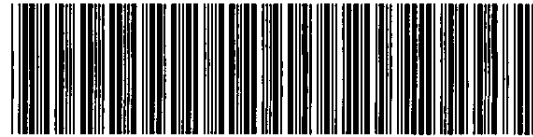

I am writing to you concerning the letter of refusal I received rejecting our recent application for Corporation papers in Florida. We have been and still are incorporated in the State of Indiana since 1961.

We do not do any business in Florida, except to receive donations and send them on to Haiti through the bank. We are a Non-Profit religious organization working in Haiti. We have a large mission work in Haiti, which contains an orphanage, a clinic with a doctor and about 20 mission out-station churches. The president of Haiti has visited our main compound in Saute-D'eau, Haiti twice in the past year and spoken at our Mission Headquarters. We are well known in the office of the Minister of Cult in the Government office of Port-au-Prince, Haiti.

I did not know until fairly recently that although we have been incorporated in the State of Indiana for many years that we still needed to be incorporated in Florida.

It is my understanding that we have a Florida I.D. number which is: 42-2404605. I believe that the Fed. I.D. number is 65-0013572. We have

had these numbers for a long time, so hopefully, they remain the same.

We do not buy or sell anything. It is strictly to take donations to help Haiti. I do not receive any salary. I donate my time.


I realize that we need to pay our back fees for not looking into this better, but is there any way that the fine of \$500.00 could be forgiven? We surely would appreciate it.
