ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 621.12 of the Florida Professional Service Corporation Act and Section 607.1006(1) of the Florida Business Corporation Act, the undersigned Corporation, in order to remove itself from Chapter 621 of the Florida Professional Service Corporation Act and to bring itself solely under the provisions of Section 607 of the Florida Business Corporation Act, hereby adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is DENNIS D. JUNGERBERG, M.D., P.A.

2. The following amendments to the Articles of Incorporation were adopted by the Shareholders of the Corporation on the 11th day of March, 2005, in the manner prescribed by the Florida Business Corporation Act:

(a) The Article referring to the name is hereby amended to read as follows: "The name of the Corporation shall be JUNGERBERG MEDICAL, INC."

(b) The capital stock provision of the Articles of Incorporation are hereby amended to provide that the Corporation shall have the authority to issue 1,000 shares of common stock, no par value.


(c) The Articles of Incorporation are amended in order to remove all reference to the requirements of rendering professional services as required by Chapter 621 of the Florida Professional Service Corporation Act and the Corporation agrees to be governed under the provisions of Section 607 of the Florida Business Corporation Act.

3. The number of votes cast for the amendment by the Shareholders was sufficient for approval.


