The purpose of the enclosed documents is to correct a recently discovered filing error that occurred in 2002 when my client was registered as a foreign entity in Florida. Specifically, the Florida attorney who filed the application for foreign registration was apparently unaware that Parelli had voluntarily dissolved its California corporation (Parelli Natural Horse-Man-Ship, Inc. of California) and reorganized in Colorado (Parelli Natural Horse-Man-Ship, Inc. of Colorado) on October 18, 2002, only days before he filed the application here in Florida. Accordingly, when the attorney prepared the documents, he incorrectly identified the California corporation as the entity to be registered in Florida, rather than the Colorado corporation. Every year since, the same attorney has attended to filing the requisite Annual Reports. I became aware of this error recently while reviewing the client's records. Having spoken with one of your staff, I understand that this type of error cannot be corrected by way of an amendment to the existing registration and that a new application for foreign registration must be submitted. If this is incorrect, please let me know. Accordingly, I am enclosing herewith for filing of record the following documents:

- 1. An Application by Foreign Corporation for Withdrawal of Authority to Transact Business in Florida in connection with Parelli Natural Horse-Man-Ship, Inc. of California (now dissolved);
- 2. An Application by Foreign Corporation to Transact Business in Florida together with the required Certificate of Good Standing for Parelli Natural Horse-Man-Ship, Inc. of Colorado; and
- 3. A check in the amount of \$131.25 for the filing fees.

I am aware that certain Florida Statutes provide for the imposition of penalties for failure to register as a foreign entity prior to conducting business in Florida. However, the imposition of penalties would not be justified in this case because: 1) Parelli attempted in good faith to comply with the registration statutes by filing an application for registration and paying the required fee, 2) the recitation of the entity name, principle address, mailing address, registered agent and Federal Employer Identification No. (FEIN) were all correctly stated in the original application, 3) the improperly listed State of incorporation was unintentional, 4) Parelli has, since the initial registration filing, caused to be timely filed through its Florida attorneys the required Annual Reports for

every year to date and paid the required fees. It should be apparent that this is simply not a case where a foreign entity was ignoring its duty to be registered such that the imposition of sanctions would be warranted. Rather, it was an innocent mistake and one that was not easy to detect given that the Annual Reports filed each year since the initial registration do not include the State of organization, but do properly state the name of the corporation and EIN. Based on the above, I request that penalties not be imposed on my client.
