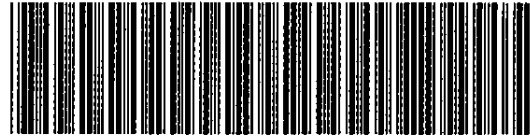



Purposes, functions, and activities of the Organization:

The United States Olympic and Paralympic Foundation was incorporated to operate exclusively for charitable and educational purposes, and to operate for the benefit of the United States Olympic Committee (USOC) specifically to generate philanthropic support for the USOC. The United States Olympic Committee was incorporated by Congress for the purpose of establishing national goals for amateur activities and to aid and encourage the attainment of these goals. The Committee is charged with the task of coordinating and developing amateur athlete activity in the United States, which directly relates to international amateur athlete competition. In addition, the Committee exercises exclusive jurisdiction over all matters pertaining to the participation of the United States in the Olympic, Paralympic, and Pan-American Games. The Committee also represents the United States as its National Olympic Committee in relations with the International Olympic Committee and the Pan-American Sports Organization, and as National Paralympic Committee with the International Paralympic Committee.
