### EXHIBIT A STATEMENT OF CORPORATION'S PURPOSES

The following are excerpts from the Corporation's Articles of Incorporation setting forth the Corporation's purposes in home state to be carried out in Florida:

#### ARTICLE II.

- (a) This corporation is not organized for pecuniary profit or financial gain, and no part of its assets, income or profit shall be distributable to, or inure to the benefit of its members, directors or officers except to the extent permitted under the Not-for-Profit Corporation Law.
  - (b) The corporation shall have no stockholders, and no part of its net earnings shall enure to the benefit of any private shareholder (if there ever be any), member or other individual.
- (c) Subject to the direction of a court of competent jurisdiction, in the event of the dissolution of the corporation, any of its assets which may remain after payment or satisfaction of all proper claims and demands then existing against the corporation, and after lawful provision for the administration or disposition of any property held in trust by or for the corporation, shall be distributed to or among one or more corporations, trusts, community chests, funds or foundations organized and operated exclusively for charitable, religious, scientific, literary or educational purposes, no part of the net earnings of which enures to the benefit of any private shareholder or individual and no substantial part of the activities of which

#### ARTICLE III.

The purposes for which it is to be formed are:

- (a) To acquire or receive in any manner and to maintain and administer any property of whatsoever nature, real, personal or mixed, tangible or intangible; to have, hold, control, manage, sell and exchange the same, to invest and relinvest the same and the proceeds thereof, and to collect and receive the income and profits thereof.
- (b) To hold and use the said property and the proceeds thereof, to distribute the whole or any part of the said property and proceeds, and to apply the entire income therefrom, after payment of necessary expenses of operation, exclusively for charitable, religious, scientific, literary or educational purposes, (i) by granting free and voluntary aid and assistance to any one or more corporations, trusts, community chests, funds or foundations organized and operated exclusively for charitable, religious, scientific, literary or educational purposes, no part of the net earnings of which enures to the benefit of any private shareholder or individual and no substantial part of the activities of which is carrying on propaganda or otherwise attempting to influence legislation, and/or (ii) by itself conducting, establishing or maintaining charitable, scientific, literary or educational activities; provided, however, that the corporation shall not engage in any activity in the State of New York which under the provisions of Section 11 of Article II of the Membership Corporations Law requires the approval or consent of any state board, department, commission, officer or of any society, association or other organization.
- (c) To do all things necessary and useful for the fulfillment and promotion of its purposes.
