FOURTH: The corporation is a corporation as defined in Section 120(a)(5) of the Not-for-Profit Corporation Law.

SIXTH: The amendments effected by this Certificate of Amendment are as follows:

- (a) Paragraph First of the Certificate of Incorporation relating to the corporate name is hereby amended to read in its entirety as follows:
  - "1. The name of the corporation shall be: The Rayonier Advanced Materials Foundation."
- (b) Paragraph Fourth of the Certificate of Incorporation relating to the principal office of the corporation is hereby amended to read in its entirety as follows:
  - "4. The County within the State in which the principal office of the corporation will be located in is the County of Albany, State of New York."

SEVENTH: The Secretary of State is designated as agent of the corporation upon whom process against it may be served.
