ARTICLES OF AMENDMENT

OF

NNE PHARMAPLAN, INC.

Pursuant to North Carolina General Statutes Section 55-10-06, the undersigned corporation (the "Corporation") hereby submits these Articles of Amendment for the purpose of amending its Articles of Incorporation:

- 1. The name of the Corporation is NNE Pharmaplan, Inc.
- 2. The following amendments to the Articles of Incorporation were duly adopted on December 15th, 2016 in the manner prescribed by law,

Article I of the Articles of Incorporation is hereby deleted in its entirety and the following new Article I is hereby substituted in lieu thereof:

"The name of the corporation shall be "NNE, Inc,"

- 3. The amendment does not provide for the exchange, reclassification, or cancellation of issued shares.
- 4. Shareholder approval of the amendment was obtained as required by Chapter 55 of the General Statutes of North Carolina.
- These Articles will be effective as of February 1, 2017.
