To Whom It May Concern:

We are writing to you on behalf of Screen Actors Guild – American Federation of Television and Radio Artists, a non-profit non-stock corporation incorporated in Delaware. We are writing this letter to request that the Florida Department of State, through its Division of Corporations, accept our client's application for authorization to conduct its affairs in Florida under its actual corporate name rather than requiring this labor union to add a fictitious "inc." to its name, which would be confusing to the public and highly inappropriate given its union function.

The Screen Actors Guild – American Federation of Television and Radio Artists is a widely recognized American labor union that represents more than 165,000 artists and media professionals across the country. It operates as a non-profit labor union for the good of its professional members. As you know, since the beginning of labor unions in the United States 150 years ago, unions do not act as traditional corporations, and it would be antithetical to ask them to fictitiously parade as such.

Fortunately, Sections 617.1505(1) and 617.0401(1)(a) of the Florida Statutes contain an appropriate exception for our client. Those sections do not require that all names of foreign entities contain the word "corporation" or "incorporated". Instead, they provide flexibility by allowing words or abbreviations of like import.

In compliance with these sections, our client's name contains such words of like import, in particular both the words "guild" and "federation". Both of these words independently signal the existence of an incorporated entity.


Our client not only complies with the words, but also the spirit of the Florida Statutes. The purpose of these Sections is to ensure that not for profit entities are properly distinguished from natural persons, unincorporated associations, and partnerships. Our client's name clearly identifies its status as an incorporated entity.

Screen Actors Guild – American Federation of Television and Radio Artists was duly incorporated in Delaware on the basis of the words "guild" and "federation" without the need for the words "inc." or "corporation". It has registered as a foreign corporation in numerous other states under its real name, without any issues, including several states which have substantially similar wording to the Florida Statutes. It is both a non-stock and a non-profit entity, and is certainly not the equivalent of traditional for-profit corporations that use "inc." or "corporation" in their names.

If you did not permit our client to register under its actual name, your denial would in effect be asking it to parade under a misleading and fictitious name in your state. That would be confusing to thousands of union members who rely on it to serve its union function – not to act as a corporation.
