ARTICLES OF INCORPORATION

Pursuant to the provisions of the Colorado Business Corporation Act, as amended, the Corporation adopts the following Articles of Amendment to the Articles of Incorporation:

1. The name of the corporation is Sentis USA Inc. (the "**Corporation**"), and the date of filing of the original Articles of Incorporation of the Corporation with the Secretary of State of Colorado was August 23, 2006 (the "**Articles of Incorporation**").

2. Paragraph No. 1 of the Articles of Incorporation is hereby amended and restated to read in its entirety as follows:
