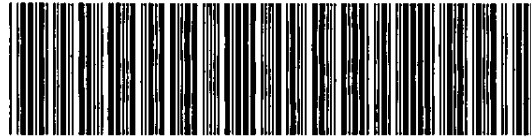

I am writing to you to appeal your letter dated September 25, 2014 denying the application of the Royal Newfoundland Constabulary Association to become a foreign not for profit corporation in Florida. It is my understanding that the application was denied due to two matters, which I will elaborate on below; omission of members addresses and the date of business activity in Florida stated as prior to the original application of registration.

The Royal Newfoundland Constabulary is a Canadian police service based in Newfoundland, Canada. The Royal Newfoundland Constabulary Association, "the Association", represents the 380 non-commissioned police officers of the Royal Newfoundland Constabulary. The Association sought to purchase a home in Florida for investment purposes in addition to offering the property as a vacation rental to the Association's members. Upon commencement of evaluating whether purchasing in Florida would be a viable financial investment, we did not register as a Florida Incorporation as we were not conducting any business or earning any income.


On August 15, 2014 we purchased a home in Florida. In order to commence service with various utility companies, we began the process of becoming a registered foreign not for profit corporation in Florida. It was after submitting this original application that we received your letter advising of the penalty with regard to Line 6 of the aforementioned application. We are now resubmitting our application with the correct date as August 15, 2014 as it properly reflects the date upon which we took ownership of the property. It should be noted that we have yet to commence receiving any income from this property.

As per your request, please find enclosed the corrected original, one copy of the document, along with your original letter. I apologize for the oversight in completion of these documents. I trust that these revised document, along with this letter of explanation will suffice to reverse the \$561.25 in civil penalty and annual report filing fees and will result in the reinstatement of the corporation filing process.




