CERTIFICATE OF AMENDMENT OF THE CERTIFICATE OF INCORPORATION OF ZENITH EDUCATION GROUP, INC.

December 5, 2019

Zenith Education Group, Inc. (the "<u>Corporation</u>"), a non-stock corporation organized and existing under the General Corporation Law of the State of Delaware (as amended from time to time, the "<u>General Corporation Law</u>"), does hereby certify as follows:

FIRST: That the Corporation filed its original Certificate of Incorporation with the Delaware Secretary of State on September 17, 2014.

SECOND: This Amendment to the Corporation's Certificate of Incorporation (the "<u>Certificate</u>") has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law by the directors of this corporation.

THIRD: Article First of the Certificate is deleted in its entirety and replaced with the following:

"FIRST: The name of the corporation is ECMC Education, Inc. (the "Corporation")"

FOURTH: This Amendment shall become effective on January 1, 2020 at 12:00 a.m.
