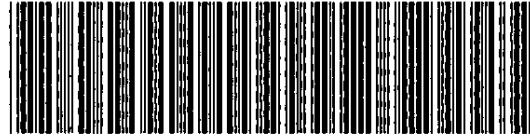



## **Additional Information for Florida Registration**

### **Focus on the Fight Corporation 47-2679561**

#### **Purpose**

Focus on the Fight is a non-profit corporation and shall be operated exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

Focus on the Fight's purpose is to address, educate, coordinate, and provide opportunities and resources to aid families faced with the challenges of caring for a loved one who has been diagnosed with cancer.

Having someone you care about be diagnosed with cancer is beyond difficult. It is life changing, for both you. You instinctively want to do everything in your power to help her focus on fighting the cancer and maintain quality of life. You also want to spend as much time as you possibly can with her, especially if the diagnosis is terminal. At the same time, food must be bought and cooked, laundry cleaned, dishes washed, homes cleaned, dogs walked, bills paid, jobs worked, cars serviced, lawns mowed, and a host of other activities. The mission of Focus on the Fight is to provide the support and resources to take care of all of those less important activities so families can make the most of the time that has been afforded to them and help their loved one with cancer focus on treatment, staying health, and quality of life. To focus on fighting and overcoming the heartbreaking ordeal that is being diagnosed with cancer. Every minute, every hour we able to give back supports true quality of life.

To accomplish this, Focus on the Fight will partner with and contract out these services to existing business. Focus on the Fight will coordinate the completion of these services on behalf of the cancer patients and their families that we will be working with.

Our programs may include sending out ambassadors to raise social consciousness about the cause on a local and eventually national level, and to hold fundraising events in order to have the maximum impact from the events that we hold and causes we support.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c)(3) section of the internal revenue code and are operated exclusively for educational and charitable purposes.

At times, per the discretion of the board of directors, we may provide internships or volunteer opportunities which shall provide opportunities for involvement in said activities and programs in order to have a greater impact for change.

#### **Public Benefit**

Focus on the Fight is designated as a public benefit corporation.

## **Non-profit Nature**

Focus on the Fight is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of Focus on the Fight shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Focus on the Fight is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual.

## **Dissolution**

Upon termination or dissolution of Focus on the Fight, any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the 1986 Internal Revenue Code (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of the Focus on the Fight hereunder shall be selected in the discretion of a majority of the managing body of the corporation, and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against Focus on the Fight, by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Colorado.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to Focus on the Fight, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Colorado to be added to the general fund.


### **Prohibited Distributions**

### **Restricted Activities**

No part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.
