CERTIFICATE OF AMENDMENT TO THE CERTIFICATE OF INCORPORATION OF GREENSILL CAPITAL MANAGEMENT COMPANY (US) INC.

GREENSILL CAPITAL MANAGEMENT COMPANY (US) INC. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "DGCL"), does hereby certify as follows:

- By unanimous joint written consent of the board of directors and the sole shareholder of the Corporation, resolutions were duly adopted, in accordance with the provisions of Sections 141 and 228 of the DGCL, setting forth an amendment to the Certificate of Incorporation of the Corporation (the "Amendment") and declaring such Amendment to be in the best interests of the Corporation.
 - The resolution setting forth the Amendment is as follows:

RESOLVED, that the Certificate of Incorporation of this Corporation be amended by changing Article FIRST and SECOND so that, as amended, said Articles shall be and read as follows:

'FIRST: The name of the Corporation shall be: GREENSILL CAPITAL INC.

SECOND: Its registered office in the State of Delawere is to be located at 850 New Burson Road, Suits 201, Dover, Kent County, Delaware 19904, and its registered agent at such address is NATIONAL CORPORATE RESEARCH, LTD.'

RESOLVED, that the Corporation shall file with the Delaware Department of State the Amendment to effectuate such changes, and such Amendment be, and is hereby, approved, adopted, and confirmed in all respects.

- 4. The foregoing amendment was duly adopted in accordance with the provisions of Sections 141 and 228 of the General Corporation Law of the State of Delaware.
