EXHIBIT A

AFRICAN VISION OF HOPE

The purposes for which the corporation is organized are:

The purpose of the corporation is to operate exclusively for charitable, religious, educational and scientific purposes within the meaning of Section 501(c)(3) of the Code. In particular, the corporation's primary purposes are:

- (A) To spread God's love for the people of the African continent through the preaching of the Gospel of Jesus Christ and through the provision of humanitarian aid, including, without limitation, food, shelter and medical care and supplies.
- (B) To assist the people of the African continent in improving their lives through the provision of practical training, including, without limitation, job skills training, life skills training and spiritual training, and basic education, including, without limitation, primary education and secondary education.
- (C) To coordinate and work with other religious, humanitarian, and educational organizations, whether based in the United States, Africa or elsewhere, and individuals, in achieving these goals, subject to the corporation's criteria for approval of collaborating organizations.

In addition, the Corporation may engage in any and all other lawful activities that are:

- (A) Approved by the Board of Directors of the corporation;
- (B) Appropriate for a nonprofit corporation organized under the Illinois General Not for Profit Corporation Act; and
- (C) Appropriate for a corporation which is exempt from taxation under Section 501(c)(3) of the Code.

All of the assets and the earnings of the corporation shall be used exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Code, and shall be subject to the following additional limitations:

(A) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its trustees, directors, officers,

or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above.

- (B) No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene (including the publishing or distribution of statements) in any political campaign on behalf of any candidate for public office.
- (C) Notwithstanding any other provision contained herein, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (ii) by a corporation, the contributions to which are deductible under Section 170(c)(2) of the Code.
