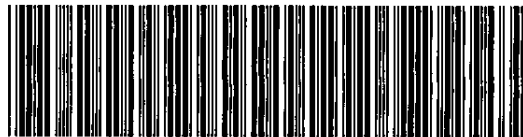

OF

I hereby form a stock corporation under the provisions of Chapter 9 of Title 13.1 of the Code of Virginia, and to that end set forth the following:

(a) The name of the Corporation is ComByte USA, INC.

(b) The purposes for which the Corporation is organized are the transaction of any or all lawful business, not required to be specifically stated in these articles of incorporation, for which corporations may be incorporated under the Virginia Stock Corporation Act.

(c) The aggregate number of shares which the corporation shall have the authority to issue shall be One Thousand (1,000); which shall consist of one class only, known as common shares.
