Pursuant to the provisions of Sections 10A-2A-10.01 through 10A-2A-10.09 of the Alabama Business Corporation Law, as amended, (the "Law"), the undersigned corporation adopts the following Certificate of Amendment to its Certificate of Incorporation:

FIRST: The name of the corporation is First Protective Insurance Group, Inc. (the "Corporation"). The Alabama Entity ID Number of the Corporation is 091-542.

SECOND: The Certificate of Incorporation of the Corporation is hereby amended effective as of the date set forth in Section Sixth below to effect a change to the name of the Corporation. Paragraph 1 of the Certificate of Incorporation of the Corporation is hereby deleted in its entirety and the following shall be substituted in lieu thereof:
