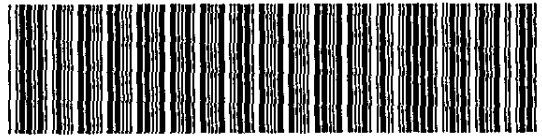

RESOLVED:


1. All of the recitals are approved and adopted by all of the directors and shareholders of Deltona-Marco Properties, II, Inc.
