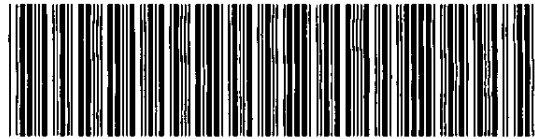

We have been instructed by the Corporate Filings Section to forward this letter to your attention.


On January 30, 2017, our office electronically filed Articles of Dissolution for the above-referenced Florida limited liability company with the Department of State. The Articles of Dissolution were processed and accepted.

Following the dissolution, we submitted the enclosed Resolution of the Board of Directors to Withdraw the Alternate Name for Use in Florida (the "Resolution") to rescind the alternate name "American Outdoor Brands Corporation of Nevada" and to begin using the name American Outdoor Brands Corporation for Document No. L16000000737. The Resolution was rejected with the notation that the name of the dissolved entity is held for a period of 120 days after the dissolution, and therefore, the name is not available for our use.

Please note that the two entities referenced herein have the same principals. We do not have any intention of reinstating L16000227357, and we hereby release the name for use by American Outdoor Brands Corporation, Document No. 16000000737.
