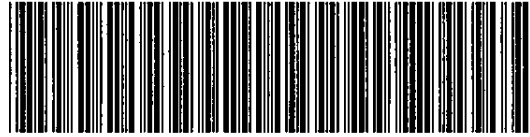



### 2010 New York Code

#### RCO - Religious Corporations

#### Article 2 - (3 - 27) GENERAL PROVISIONS

#### 3 - Filing and recording certificates of incorporation of religious corporations.

§ 3. Filing and recording certificates of incorporation of religious corporations. The certificate of incorporation of a religious corporation shall be acknowledged or proved before an officer authorized to take the acknowledgment or proof of deeds or conveyances of real estate, to be recorded in the county in which the principal office or place of worship of said corporation is or is intended to be situated, and **shall be filed and recorded in the office of the clerk of said county.**
