





The Corporation is authorized to issue an unlimited number of Class A shares and an unlimited number of common shares.

7. Rights, privileges, restrictions and conditions (if any) attaching to each class of shares and directors authority with respect to any class of shares which may be issued in series:

1. The holders of the Class A shares shall be entitled to receive and the Corporation shall pay thereon as and when declared by the board of directors of the Corporation out of the assets of the Corporation properly applicable to the payment of dividends, dividends in such amounts as shall be determined by the board of directors.
  2. The Corporation may redeem the whole or any part of the Class A shares on payment for each share to be redeemed of an amount equal to \$1.00 (herein referred to as the "Redemption Amount") plus dividends declared thereon and unpaid. In case a part only of the then outstanding Class A shares are at any time to be redeemed the shares so to be redeemed shall be selected by lot in such manner as the directors in their discretion shall decide or, if the directors so determine, may be redeemed proportionally disregarding fractions, and the directors may make such adjustments as may be necessary to avoid redemption of fractional parts of shares.
  3. Any holder of Class A shares shall be entitled to require the Corporation to redeem at any time all or any of the Class A shares registered in the name of such holder on the books of the Corporation. The Corporation shall redeem such Class A shares by paying to such registered holder for each such Class A share being redeemed, the Redemption Amount plus all dividends declared thereon and unpaid.
  4. In the event of the liquidation, dissolution or winding-up of the Corporation or other distribution of the property of the Corporation among shareholders for the purpose of winding-up its affairs, the holders of the Class A shares shall be entitled to receive from the property of the Corporation a sum equivalent to the aggregate Class A Redemption Amount of all of the Class A shares held by them respectively plus all dividends declared thereon and unpaid before any amount shall be paid on the property of the Corporation distributed to the holders of the common shares or any other shares ranking junior to the Class A shares. After payment to the holders of the Class A shares of the amount so payable to them as above provided they shall not be entitled to share in any further distribution of the property of the Corporation.
  5. The holders of the Class A shares shall not be entitled to receive notice of or to attend any meeting of the shareholders of the Corporation unless the meeting is called to consider any matter in respect of which the holders of the Class A shares would be entitled to vote separately as a class, in which case the holders of the Class A shares shall be entitled to receive notice of such meeting. The holders of the Class A shares shall not be entitled either to vote at any meeting of the shareholders of the Corporation or to sign a resolution in writing, except a meeting called to consider, or a resolution in writing in respect of, any amendment to these Articles in respect of which the holders of the Class A shares would be entitled to vote separately as a class pursuant to the Business Corporations Act.
  6. The holders of the common shares are entitled:
    - (i) to one (1) vote per share at all meetings of shareholders except meetings at which only holders of a specified class of shares are entitled to vote;
    - (ii) subject to the rights, privileges, restrictions and conditions attaching to any class or series of shares of the Corporation, to receive any dividends declared payable by the Corporation on the common shares; and
    - (iii) subject to the rights, privileges, restrictions and conditions attaching to any class or series of shares of the Corporation, to receive the remaining property of the Corporation upon dissolution.

8. The issue, transfer or ownership of shares is/is not restricted and the restrictions (if any) are as follows:

- (ii) the previous express sanction of the directors of the Corporation expressed by a resolution passed at a meeting of the directors or by an instrument or instruments in writing signed by a majority of the directors.


