

Addendum I - Purpose Clause - National Church Residences Foundation

The Corporation is organized and is to be operated exclusively for charitable and educational purposes as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States internal revenue law (the "Code"), including for such purposes, the making of distributions to organizations which qualify as exempt organizations under Section 501(c)(3) of the Code or the Secretary of the United States Department of Housing and Urban Development, exclusively for a public purpose. In pursuance of the foregoing purposes, the Corporation shall have the power to provide elderly person and handicapped persons with housing facilities and services specially designed to meet their physical, social, and psychological needs, and to promote their health, security, happiness, and useful longer living, maintenance, and operation thereof on a nonprofity basis. The Corporation shall be operated exclusively for the benefit of, to perform the functions of, to carry out one or more of the purposes of, and to be a supporting organization for its sole member, National Church Residences, an Ohio nonprofit corporation and Section 501(c)(3) organization.

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth above. No loans shall be made by the Corporation to its directors or officers. No substantial part of the activities of the Corporation shall be the carryong on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or against any candidate for public officer. Notwithstanding any other provision, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (b) by a corporation, contribution to which are deductible under Sections 170(c)(2), 2055, 2016(a)(2)(A), and 2522 of the Code. The Corporation hereby expresses the continuing intent to qualify as a tax exempt entity under Section 501(c)(3) of the Code.

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, distribute all the assets of the Corporation in such manner, or to such organizations organized and operated exclusively for religious, charitable, educational, or scientific purposes as shall, at the time qualify (i) as an exempt organization or organizations under Section 501(c)(3) of the Code, or (ii) as a state, a possession of the United States, or any political subdivision of any of the foregoing, or the United States, or the District of Columbia (provided that the distribution is for a public purpose), in each case as the Board of Directors of the Corporation shall determine. Any of such assets not so disposed of shall be disposed of by the Court of Common Pleas of the Ohio in which the principal office of the Corporation is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
