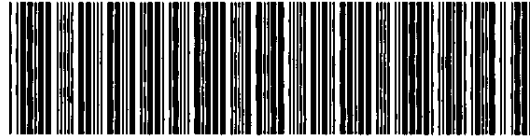

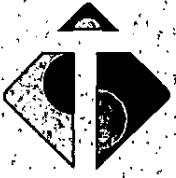

This letter is in response to Letter #516A00007654 received by Talent Services from your office.

This letter states that there is a civil penalty and annual report filing fees in the amount of \$3050.00 owed to the Division of Corporations.

Under the 2015 Florida Statute 607.1501, Authority of foreign corporation to transact business required it states: (j) Conducting an isolated transaction that is completed within 30 days and that is not one in the course of repeated transactions of a like nature.


Talent Services works as part of a team with ad agencies, casting directors, talent, talent agencies, crew, producers, etc. within the media agency. We are a Washington Corporation, and all of our assets, property, etc. are in the state of Washington.

Talent Services does not have many productions in the state of Florida and all of them have been produced and completed well within the 30 days per the statute (usually 1-3 day production). We work in a very unique industry. We are required by law to cover Florida workers for Re-employment Insurance and worker's compensation, however, Talent Services does not have a place of business in Florida. This has never been an issue since up until 4/1/2016, we have had a multi-state policy for worker's comp. through a private company.

Talent Services does not have any scheduled productions for 2016. This can change if we decide to do a location shoot in the state of Florida, but that is uncertain at this time.

If the state of Florida determines that we register with the Division of Corporations for the potential of future jobs, Talent Services would be willing to do so if the penalty and annual filings are waived.
