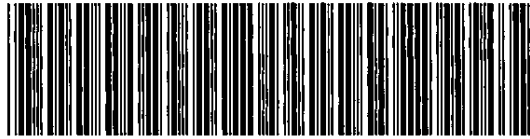

Dear Mr. Smith:

Shutts & Bowen represents Boston Private Bank & Trust Company (the "Bank") in connection with the Bank's application for a certificate of authority to transact business in Florida. Although the Bank may wish to establish a full-service branch office in Florida in the future, at present, the activities of the Florida office would be limited to those of a loan production office and related incidental activities.

The Bank is a Massachusetts trust company, organized pursuant to Chapter 172 of the Massachusetts General Laws and under its charter is authorized to conduct a general commercial banking business in addition to exercising its fiduciary powers. In this regard, the Bank is an FDIC-insured state non-member bank subject to supervision and examination by the Massachusetts Commissioner of Banks and the Federal Deposit Insurance Corporation (the "FDIC"). The Bank maintains branch offices in Massachusetts and California but currently has no physical presence in Florida.


In connection with the proposed activities, the Bank anticipates filing with the Secretary of State an Application by a Foreign Corporation for Authorization to Transact Business (the "Application") in Florida. A copy of the proposed Application is attached for your review and further information. We also include the completed corporate name approval request form. Since the filing of the Application with the Florida Department of State will require the consent of the Office of Financial Regulation, it would be greatly appreciated if you would forward the enclosed materials to the Florida Secretary of State's office for processing if they meet your approval.

Reference is made to your recent letter requesting approval to register the above-referenced fictitious name with the Florida Secretary of State by Boston Private Bank & Trust Company, which is a Massachusetts state-chartered bank headquartered in Boston, Massachusetts.

Section 655.922, Florida Statutes, exempts a financial institution, holding company or its subsidiaries from the prohibition of using the word "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union," or words of similar import, in any context or in any manner in its corporate name. Therefore, this Office will not object to the use of the above referenced name being registered to transact business in the state of Florida. However, this correspondence is not intended to grant the authority to act in any licensed capacity until all licensing requirements have been met within this state.

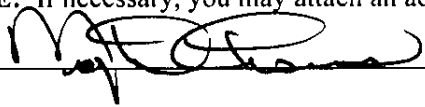

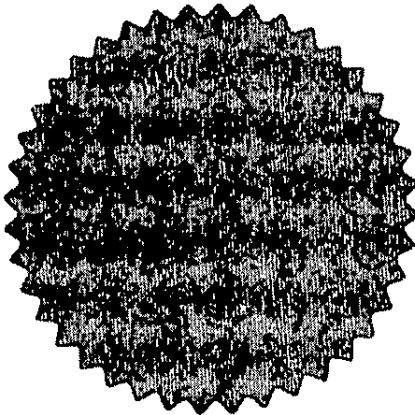
