"The aggregate number of shares which the Corporation is authorized to issue is: 200,000 shares of stock, consisting of 100,000 shares of voting common stock having no par value, and 100,000 shares of non-voting common stock having no par value.

The entire voting power of the Corporation shall be vested in the holders of the voting common stock.
