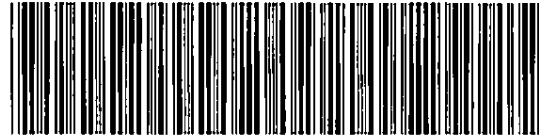




**ARTICLES OF DISSOLUTION


