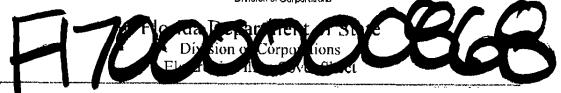

Reference is made to your recent letter requesting approval to register the above-referenced fictitious name with the Florida Secretary of State by Goldman Sachs Bank USA, which is a New York state-chartered bank headquartered in New York, NY.

Section 655.922. Florida Statutes, exempts a financial institution, holding company or its subsidiaries from the prohibition of using the word "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union," or words of similar import, in any context or in any manner in its corporate name. Therefore, this Office will not object to the use of the above referenced name being registered to transact business in the state of Florida. However, this correspondence is not intended to grant the authority to act in any licensed capacity until all licensing requirements have been met within this state.

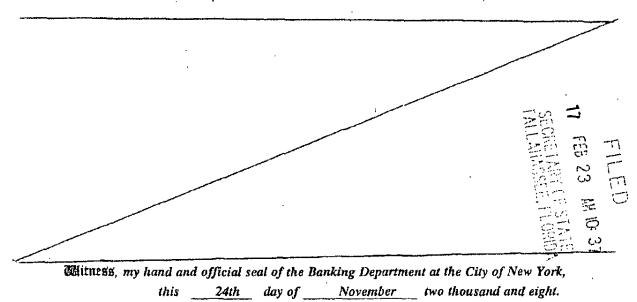

We, the undersigned, <u>Mitchell Lieberman</u> and <u>Matthew Tropp</u>, being the <u>Chairman</u> and <u>Assistant Secretary</u>, respectively, of The Goldman Sachs Trust Company, hereby certify as follows:

- 1. The name of the corporation is The Goldman Sachs Trust Company.
- The Organization Certificate of The Goldman Sachs Trust Company was filed by the Superintendent of Banks of the State of New York on August 20, 1990.
- The Organization Certificate is hereby amended by deleting articles FIRST, THIRD and NINTH in their entirety and substituting in lieu thereof the following:

"FIRST. That the name by which the corporation is to be known is Goldman Suchs Bank USA.

THIRD. That the amount of its capital stock is to be Eight Billion Dollars (\$8,000,000,000), and the number of shares into which such capital stock is to be divided is 80,000,000 with a par value of \$100 each.

NINTH. That the Corporation is to exercise the powers conferred by Section 100 of the Banking Law in addition to the other powers conferred upon banks in Article 3 of the Banking Law."

4. The foregoing amendments of the Organization Certificate were authorized on November 19, 2008 by written consent of The Goldman Sachs Group, Inc., the sole holder of 100% of the outstanding capital stock of The Goldman Sachs Trust Company.
