AGENCY AGREEMENT

SRQ PROPERTY LAW, PLLC, a Florida limited liability company ("SRQ"), hereby agrees with WB SERVICES INC., existing under the laws of Ohio (the "Principal"), to serve as the Principal's appointed registered agent in the State of Florida under Section 605.0113, Florida Statutes. By appointing SRQ as its registered agent, the Principal is not committed to employ SRQ, to represent it, nor is SRQ committed to represent the Principal, in any legal action or proceeding, or to take any action not specified herein. The Principal shall indemnify SRQ and hold SRQ harmless from and against all losses, damages, fines, penalties, liabilities, and expenses (including attorneys' fees) resulting from or arising out of SRQ's service as agent hereunder, except to the extent caused by SRQ's willful or reckless conduct.

In the event a subpoena is served upon SRQ pursuant to the Florida Statutes, the Principal agrees to promptly furnish to SRQ any and all testimony or records that may be required to be produced by such subpoena.

SRQ's fee for this service is \$150.00 per calendar year, billed in advance. SRQ may resign at any time upon 30-days written notice to the Principal.

Pursuant to Section 605.0212 of the Florida Statutes and on an annual basis, all Florida limited liability companies are required to file an Annual Report with the State of Florida by May 1. If the report is not filed by the deadline, the company will be subject to a late filing fee penalty. Annual Report filings are not included in the Registered Agent services described in this Agreement. The Principal is solely responsible for ensuring that the Annual Report is filed timely.
