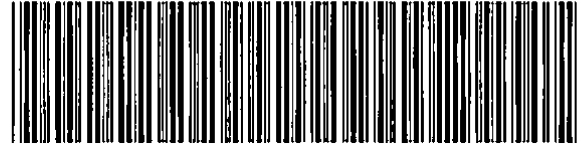

**CERTIFICATE OF AMENDMENT
OF THIRD AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF ACEND, INC.**

ACEND, INC. (the "**Corporation**"), a corporation duly organized and validly existing under the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. Paragraph 1 of the Corporation's Third Amended and Restated Certificate of Incorporation, filed with the Secretary of State on October 9, 2018 (the "**Certificate of Incorporation**"), is hereby amended and restated in its entirety as follows:

"1. That the name of this corporation is REIN Technologies (US) Inc. (the "**Corporation**"), that this corporation was originally incorporated pursuant to the General Corporation Law on March 6, 2015 under the name PlatformBrown, Inc., and that this corporation previously changed its name to Acend, Inc., pursuant to the General Corporation Law on April 28, 2017."

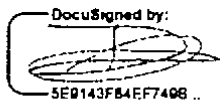
2. Paragraph 2 of the Certificate of Incorporation amended and restated in its entirety the Corporation's Second Amended and Restated Certificate of Incorporation. The "**FIRST**" Article of the Corporation's Certificate of Incorporation is hereby amended and restated as follows:

"**FIRST:** The name of this corporation is REIN Technologies (US) Inc."

3. This amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

4. All other provisions of the Certificate of Incorporation shall remain in full force and effect.
