

A Well-Fed World has the dual-mission of increasing food security in low-income communities while working with non-governmental organizations promoting the benefits of plant-based food policies to significantly reduce global hunger, improve public health, conserve environmental resources, and curb greenhouse gases.

This purpose shall be attained by:

- analyzing the adverse impacts of animal agriculture;
- monitoring public and organization policies;
- publicizing research through print and electronic media, conferences, and other public forums;

- engaging in other activities in furtherance of this purpose that are permitted under Section 501(c)(3) of the Internal Revenue Code.

This Corporation is organized exclusively for charitable and education purposes, including the making of distributions to organizations that qualify under Section 501(c)(3) of the Internal Revenue Code. No substantial part of the activities of this Corporation shall be attempting to influence legislation, and this Corporation shall not participate in any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, this Corporation shall not engage to any substantial degree in any activities that are not in furtherance of its purpose.
