This certificate is issued by the Servicio Nacional Integrado de Administración Aduanera y Tributaria (National Integrated Service of Customs and Tax Administration) of the Bolivarian Republic of Venezuela.

The certification process in Venezuela is done strictly online, and no printed originals are issued. Once the online request is completed and the corporation is verified, the online system produces a digital certificate, which is what I am enclosing, in order to request the certificate of Status.

This same non-profit was once registered in the US in 1993, in Baltimore, Maryland, and was issued EIN 98-01 36863 (Copy attached). Unfortunately, it was not renewed for many years. We have been active internationally, and in the US, we have filed our taxes yearly, with no interruption.
