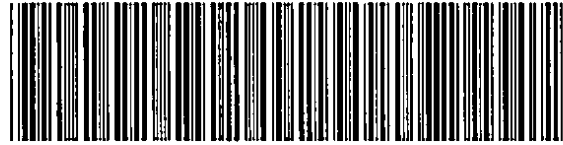





**Article I.**

The name of the corporation is Friends of Safe Schools USA, Inc.

**Article II.**

A. This corporation is a nonprofit PUBLIC BENEFIT CORPORATION and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.

B. The organizational purpose of the Friends of Safe Schools USA, Inc. is to bring school safety to the national level. We will accomplish this by offering programs designed to address current issues within our nation's education system. In addition to offering programs for students and schools we will also be offering both financial and in-kind support to schools so that they can better serve their students.

**Article III.**


