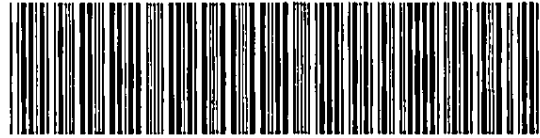

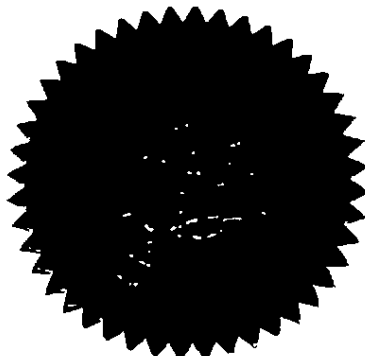

This instrument will be in force for one year, counted from its signature.

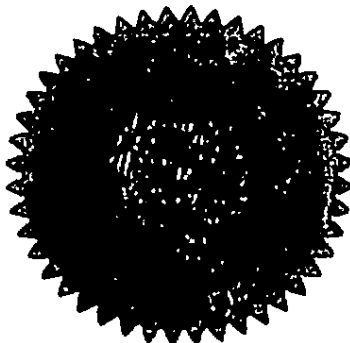


