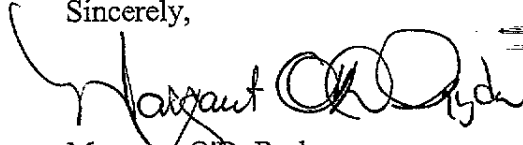

**ARTICLES OF AMENDMENT  
TO  
THE ARTICLES OF INCORPORATION  
OF  
TERREMARK, INC.**

1. The name of this corporation is Terremark, Inc., a Florida corporation, whose principal office address is 2601 South Bayshore Drive, Penthouse One, Miami, Florida 33133.

2. Article I, of the Articles of Incorporation of Terremark, Inc. is hereby deleted in its entirety and amended to read as follows:

**"ARTICLE I - NAME AND BUSINESS ADDRESS**

3. The foregoing amendment was adopted by the Directors and the sole Shareholder of the corporation on March 31, 1999, by unanimous written consent of such shareholder and directors entitled to vote.
