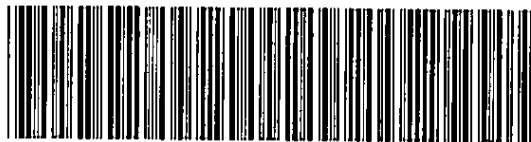

Benesch, Friedlander, Coplan & Aronoff LLP represents Triple T Transport, Inc. (SE Division) (the "Company"), a Foreign Florida Profit Corporation that is authorized to conduct business in Florida by virtue of its Registration with the Division of Corporations filed on 02/20/2018. The Company is incorporated in the state of Ohio under the name Triple T Transport, Inc. When the Company first filed for registration with the Division of Corporations, Octavia L. Simmons, Regulatory Specialist II alerted the Company that the name "Triple T Transport, Inc." was unavailable and the Company would be required to adopt an alternate corporate name for use in Florida. The document number of the conflict was identified as P06000051995. The Company thereby adopted "Triple T Transport, Inc. (SE Divisions)" as its alternative name for conducting business in the State of Florida. A true and accurate copy of the Company's registration with the Division of Corporations and the letter from Octavia L. Simmons identifying the conflicting name and the necessity to adopt an alternative name is attached hereto.

It has recently come to the Company's attention that the company with the conflicting name (Document No. P06000051995) has recently changed its entity name from "Triple T Transport, Inc." to "Pitts Trucking Inc." A true and accurate copy of the name change amendment filed by Pitts Trucking Inc. is attached hereto. Since there is no longer a conflict with an existing registered entity, the Company wishes to amend its Foreign Profit Corporation Registration to list the Company's corporate name as "Triple T Transport, Inc." to mirror its incorporation corporate name in the state of Ohio.

On 11/26/2018, the Company mistakenly filed a name change amendment and the required check totaling \$35.00 for a Florida corporation instead of a Foreign corporation. The filing was returned to the Company, with an enclosed letter identifying the mistake from Tracy L. Lemieux, Regulatory Specialist II. A true and accurate copy of that rejected filing is attached hereto. To correct the mistake, the Company hereby files the attached Application by Foreign Profit Corporation to File Amendment to Application for Authorization to Transact Business in Florida to amend its corporate entity name to "Triple T Transport, Inc." The Company sincerely apologizes for the mistaken filing.

On February 6, 2019, the Company attempted to correct its filing by filing a new name change amendment and the required check totaling \$35.00. The filing was returned to the Company, with an enclosed letter rejecting the filing from February 12, 2019. A true and accurate copy of that rejected filing is attached hereto. Company respectfully requests that the Division of Corporations approve this filed amendment.

The amendment to the Company's corporate name is not necessitated by an amendment to the Company's articles of incorporation under the laws of the state of Ohio. As such, no date has been entered in Paragraph 4 and no document evidencing a similar amendment for the state of Ohio has been submitted since the Company's incorporated corporate name has always been "Triple T Transport, Inc." Instead, the Company, since there is no longer an existing conflict with a registered Florida entity, wishes to amend its Florida corporate name to be in line with its currently corporate name under the state of Ohio. As such, the Company respectfully requests the approval of the filed amendment.


