AMENDED AND RESTATED ARTICLES OF INCORPORATION OF PROJECT COMMUNITY CONNECTIONS, INC.

The Articles of Incorporation of the Corporation are hereby amended and restated as follows:

"AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

PROJECT COMMUNITY CONNECTIONS, INC.

I. NAME

The name of the corporation (the "Corporation") is PROJECT COMMUNITY CONNECTIONS, INC.

IL NONPROFIT STATUS

The Corporation shall be a nonprofit corporation organized and operated pursuant to the Georgia Nonprofit Corporation Code and, except as provided herein, may engage in any and all activities that are lawful for a Georgia nonprofit corporation that is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or any corresponding provision of any future United States Internal Revenue law) (the "Code").

III. DURATION

The Corporation shall have perpetual duration.

IV. PURPOSES

The Corporation is organized exclusively for charitable purposes, within the meaning of Section 501(c)(3) of the Code, including, but not limited to:

- (a) assisting individuals and families experiencing homelessness in reestablishing themselves in the community and finding housing, and participating in partnerships with others to accomplish such purposes; and
- (b) engaging in and doing any lawful act in furtherance of the purpose set forth in (a) above.

V. POWERS

Except as otherwise provided in these Articles of Incorporation or in the Bylaws of the Corporation, the Corporation shall have the power and authority to do all things and everything necessary and proper for the accomplishment of any of the purposes or the
