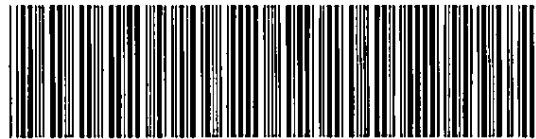

The State of Florida rejected our original foreign filing on 10/27/18.

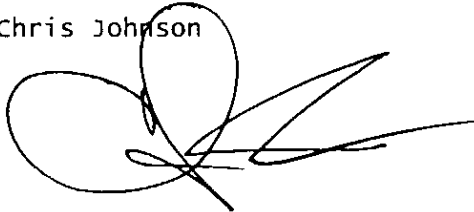
On 11/7/18, we spoke with the business division and were told that we needed to re-submit with alternate names.

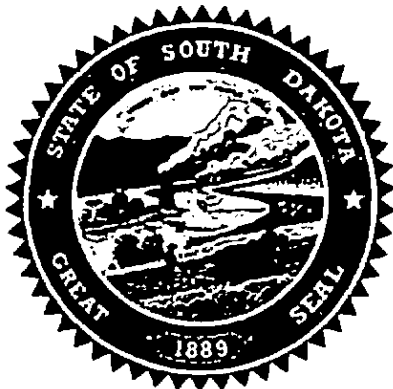
