- First: The name of the corporation is GTE Communications Corporation.
- Second: The Articles of Incorporation of this corporation are amended by changing the Article numbered 1.01 so that, as amended, said Article shall read as follows:  
  
1.01 Name - The name of this corporation shall be GTE FLORIDA BUSINESS CONNECTIONS CORPORATION.
