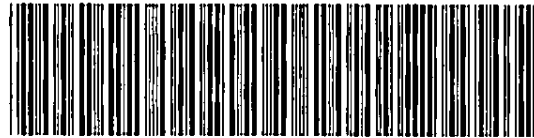

On January 2018 we sent an application to register a Foreign Company doing business in Florida.


