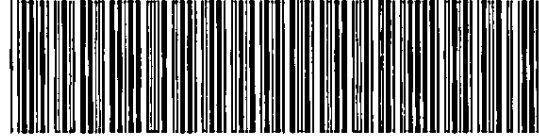

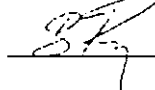

My name is Sy Ray, I am the owner and President of ZetX Corp. ZetX Corp is an Arizona based business that is registered as a corporation in good standing in the State of Arizona; #18603356.

In November of 2018, we were requested to register with Sunbiz by the City of Gainesville in order to complete a contract. This contract is for the City to have access to web-based software. The software is made, built, maintained, housed, administrated, and sold from the State of Arizona. ZetX does business in all states located within the continental United States. As such, all business conducted by ZetX outside of the State of Arizona is considered Interstate Commerce.

Interstate commerce, in U.S. constitutional law, is any commercial transactions or traffic that cross state boundaries or that involve more than one state.

Pursuant to Florida State Statute, **607.1501 Authority of foreign corporation to transact business required.**

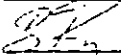
- (1) A foreign corporation may not transact business in this state until it obtains a certificate of authority from the Department of State.
- (2) The following activities, among others, **do not** constitute transacting business within the meaning of subsection (1):
 - (i) Transacting business in interstate commerce.

Given the provisions set forth in Florida State Statute 607.1501(2)(i), ZetX is not required to apply for a certificate of authority to transact business in the State of Florida, as interstate commerce is not considered transacting business in the State of Florida.

The previous document that was filed requesting ZetX to apply for a certificate of authority to transact business in the State of Florida was done mistakenly, as we were not familiar with Florida State Statute 607.1501(2)(i).
