Included in this submission are all required and applicable documents to both dissolve and re-register PRIME AE Group, Inc. (current Florida Profit Corporation Document ID #P13000062185) from a domestic corporation to a for-profit foreign corporation. Required signed applications, appropriate fees, and supporting documentation are included in this package for both processes.

Background:

PRIME AE Group, Inc. was erroneously registered in the state of Florida as a domestic corporation on July 22. 2013. This mistake was just identified and needs correction to update the entity as a foreign corporation. This error falls outside of the 30 days which Florida allows a firm to submit with the Articles of Correction. Additionally, after a few of employees called the Secretary of State Division of Corporation's office regarding this issue, we were given the same answer of needing to file as a new corporation. Hence why PRIME is filing as a new foreign corporation as per this instruction.

PRIME was not transacting in Florida prior to July 22, 2013 and has been providing annual reports since 2013, however, should there be a penalty for this incorrect domestic filing, PRIME will promptly pay the fee or provide any additional documentation.

Should the state require a different approach, direction, or have a different suggestion as to the proper steps for dissolution and re-registration, we will gladly comply. As mentioned, this was an oversight and just recently picked up. The EIN (26-0546656) for the entity, services provided in Florida, and the use of the name PRIME AE Group, Inc., would all still remain the same. As simply stated, we are trying to correct PRIME AE Group, Inc. filing as a domestic profit corporation to a foreign profit corporation.
