

This letter is to certify that records currently in the possession of the Division of Banks indicate that Berkshire County Savings Bank, Pittsfield, Massachusetts was incorporated on February 2, 1846. Effective April 1, 1996, Berkshire County Savings Bank reorganized into a mutual holding company. Berkshire Bancorp, with a subsidiary stock savings bank, Berkshire County Savings Bank which subsequently changed its name to Berkshire Bank on May 1, 1997. On June 27, 2000, Berkshire Bancorp converted to a stock holding company under the name Berkshire Hills Bancorp, Inc. Effective July 11, 2014. Berkshire Bank was converted, by operation of law, to a state-chartered trust company and it continues to operate as a state-chartered trust company under the provisions of Massachusetts General Laws chapter 172 and other related statutes, subject to supervision and examination by the Commissioner of Banks.
