We are in receipt of your letter dated September 10, 2019.

We write to confirm, as set forth in the verification below, that Advanzeon Solutions, Inc. Document Number P1700000050 with the registered agent of Young & Son's Accounting LLC, and Officer/Director Clark Marcus, is an entity (inadvertently) created by the accountant (Young & Son's Accounting, LLC) for the Delaware Corporation (Advanzeon Solutions. Inc. when they were directed to "register" the company with the State of Florida.

What the officers and directors anticipated they would do is properly register Advanzeor Solutions, Inc. as a foreign entity doing business in the State of Florida.
