**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
ROSEWOOD DEVELOPMENT CORPORATION**

Pursuant to Sections 607.1005 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of Rosewood Development Corporation, a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

**FIRST:** The name of the Corporation is Rosewood Development Corporation.

**SECOND:** Article I of the Articles of Incorporation is amended in its entirety to read as follows:

**"ARTICLE I**

**THIRD:** The foregoing amendment was adopted by the sole shareholder of the Corporation by written consent in lieu of a special meeting dated March 23, 2006. The number of votes cast by the sole shareholder for the foregoing amendment was sufficient for approval.
