

# ARTICLES OF DOMESTICATION of NATIONAL LOAN ACQUISITIONS COMPANY

### ARTICLE ONE NAME

The name of the corporation is **National Loan Acquisitions Company** (the "Corporation") which is the name of the corporation immediately prior to the filing of these Articles of Domestication, and which will continue to be the name of the corporation.
